## Gas Workshop: main policy, regulatory and infrastructure developments in the Euro-Mediterranean region

The main objective of this workshop is to share recent gas sector trends both in the Euro-Mediterranean region and worldwide, as well as to discuss the main gas interconnection projects that would affect and have an important impact on the region. MEDREG will also present the main outcomes of its recent reports on "Gas Infrastructure map" and the "Assessment of Natural Gas Competition & Market Prices in the Mediterranean Basin". All stakeholders, including International Financial Institutions (IFIs), TSOs, policy-makers, and industry, are invited to provide their views and perspectives.

The countries in our region recognize the high potential of the Mediterranean as a supplier of gas and the region's importance in terms of transit and beyond. We also acknowledge that an efficient and reliable energy system, from production and supply to transmission and distribution, is a prerequisite for national socio-economic development. Furthermore, the efficient operation of existing gas interconnectors and the development of new infrastructure to link countries and regions can contribute to integration of our economies and sharing of resources as well as a reduction of costs and risks.

One of the main purposes of regulation is to ensure a fair and transparent tariff methodology while providing high quality and reliability standards. "Stakeholders involvement" is a key factor for the success of an efficient, sustainable and forward-looking regulatory framework.

Since its establishment in 2007, MEDREG has been working to facilitate and develop a common regulatory culture and a regionally-coherent approach to energy market regulation in the Mediterranean region. MEDREG brings together 25 regulators/ministries from 21 Mediterranean countries. The Association promotes regulatory institution-building, capacity enhancement and technical cooperation with the aim to assist in the creation of a compatible, transparent and non-discriminatory regulatory framework, paving the way to the establishment of secure, sustainable and competitive Mediterranean energy markets that support stability, socio—economic development and prosperity in the region.

The discussions from the workshop will be shared within the MEDREG community as a further contribution to our ongoing efforts to accompany and anticipate developments in the natural gas sector of the region.
